We adopt this notice to comply with the Virginia Consumer Data Protection Act ("VCDPA") and any terms defined in the VCDPA have the same meaning when used in this Policy.

This Policy does not apply to workforce-related Personal Information collected from Virginia-based employees, job applicants, contractors, or similar individuals.

Your Rights and Choices

If you are a resident of Virginia, you may have rights with respect to your Personal Information, subject to applicable exceptions. Once we receive your request and confirm your identity (see Exercising Your Rights), we will review and process your request, as discussed below.

Right to Know

You may be entitled to obtain confirmation regarding whether we process your Personal Information.

Right to Access

You may be entitled to request that we disclose to you the specific pieces of your Personal Information that we have collected about you in a portable and, to the extent technically feasible, readily usable format.

Right to Deletion

You have the right to request that we delete any of your Personal Information that we collected from you and retained, subject to certain exceptions.

Right to Correct You may request that we correct Personal Information that we hold about you in the event that the Personal Information is inaccurate, taking into

- We cannot respond to your request or provide you with Personal Information if we cannot verify your identity or authority to make the request and

We will only use Personal Information provided in the request to verify the requestor's identity or authority to make it.

Response Timing and Format

We will confirm receipt of your request within ten (10) business days. If you do not receive confirmation within the 10-day time-frame, please contact us at info@cherrymanindustries.com

We endeavor to substantively respond to a verifiable Consumer request within forty-five (45) days of its receipt. If we require more time (up to another 45) days), we will inform you of the reason and extension period in writing.

If you have an account with us, we will deliver our written response to that account. If you do not have an account with us, we will deliver our written response by mail or electronically, at your option.

We will not discriminate against you for exercising any of your rights. Unless permitted under applicable law, we will not:
